GENERAL GUIDELINES

Some seats in **ONLY THREE** Lateral Entry (2nd Year) – B. Tech. Branches, i.e., in Biotechnology, Metallurgical & Materials Engineering, and Textile Engineering, and 1st Year Post-Graduate (M. Tech., M. Plan, and MBA) Programs are lying vacant in Odisha University of Technology and Research, Bhubaneswar. Therefore, interested and eligible candidates may report for the physical SPOT Admission process. It will be conducted on **13.08.2025** as per schedule given above in Room No. A-201 (Conference Hall) of the University.

In pursuance of the Order No.: SDTE-HTE-I-0003-2017/5151/SDTE, Dated: 07.08.2025; Skill Development & Technical Education Department, Government of Odisha, the SPOT Admission of 2nd Year LE – B. Tech., 1st Year M. Tech., M. Plan, and MBA courses for the Academic Year 2025-26 of Odisha University of Technology and Research, Bhubaneswar, will be conducted as follows.

- 1. The Spot Admission shall be conducted by Odisha University of Technology and Research, Bhubaneswar, for both the un-allotted seats and vacant seats as notified by OJEE-2025 and the non-reported seats arising after the final reporting and admission.
- The following category of candidates is allowed for institution-level admission against such vacant seats.
 - (i) The candidates, who have not participated in earlier rounds of OJEE counseling / who have withdrawn from the OJEE counseling process.
 - (ii) The candidates, who have participated in earlier rounds of OJEE counseling but have not been allotted of seat / allotted a seat but not considered further due to any reason.
 - (iii) The candidates who have been issued a final allotment letter after the final round of OJEE counseling but have not reported to their allotted institution.
- 3. Process for physical Spot Admission LE B. Tech. and PG (MBA, M. Tech., and M. Plan) Programs.

Date	Activities
13.8.2025 (Schedule is given above)	Reporting of candidates in person at OUTR, Bhubaneswar, with ORIGINAL Mark Sheets, Certificates, CLC/TC, and Conduct Certificate. Reporting after the scheduled time shall NOT be considered for counselling. After successful document verification and availability of seats and fulfilling the eligibility criteria, the allotment list for Spot Admission will be published.
	Allotted candidates have to pay the University Admission Fees through online mode of the University by 5.0pm, otherwise their admission stands cancelled.

4. Important Steps of Spot Admission

- (a) Submission of Demand Draft (DD) for ₹ 450/- (Rupees Four Hundred Fifty only) (Non Refundable) in favour of OUTR, Bhubaneswar, payable at Bhubaneswar towards Counseling Fee by candidates, is a prerequisite for participation in the SPOT Counseling process.
- (b) Reporting by candidates in person at the OUTR as per the above schedule with Original Certificates and Mark Sheets, one set of self-attested photocopies of all original certificates and Mark Sheets, and two numbers of passport-size photographs.
- (c) Admission will be made as per the vacant list commensurate with their rank in any particular Program / Specialization.
- (d) Admission Fee payment through online mode after publication of the allotment list.
- (e) Spot Admission process ends.
- (f) The classes start on August 18, 2025.
